II. APPROVAL OF MINUTES

 Chair Salaveria announced that the first item on the agenda is the approval of the minutes of the June 29, 2017 regular meeting. Vice Chair Mikulina moved, and Secretary Surles seconded the motion to approve the June 29, 2017 minutes. There was no discussion from the members. Chair Salaveria asked if there were comments from any members of the public. Seeing none, he called for a vote.

Ayes: Mikulina, Salaveria and Surles.

Nays: None.

The motion carried unanimously, 3 to 0.

III. REPORT OF THE EXECUTIVE DIRECTOR

 Chair Salaveria announced that the next item on the agenda is the Report of the Executive Director. Gwen Yamamoto Lau provided staffing update introducing Penny Silva who replaced Dawn Brenneman as the new Administrative and Client Services Representative.

IV. DISCUSSION AND/OR DECISION MAIKING

 Chair Salaveria announced that the next item on the agenda is the discussion of the Hawaii Sunshine Law requirements for dealing with confidential information and called on Deputy Attorney General Gregg Kinkley.

Deputy Attorney General Kinkley noted that while we had some topics of discussion in response to public questions regarding procedures of the Authority having to do with the Sunshine Law and the Uniform Information Practices Act, generally, we are unable to discuss it today as we are currently in productive discussion with the Office of Information Practices and will need to defer the matter until a later date. Chair Salaveria confirmed deferment of this item from any further discussion.

 Chair Salaveria stated the final item on the agenda is the approval of HGIA's Quarterly Report to the Hawaii Public Utilities Commission for period ended 6/30/2017. Chair Salaveria asked for a motion to approve the Quarterly Report to be filed with the PUC. Secretary Surles motioned and Vice Chair Mikulina seconded.

Chair Salaveria asked Gwen Yamamoto Lau to give an update on the quarterly report. Yamamoto Lau presented on the program status and market outlook. Items of note included: as of June 30, 2017, the program committed \$68.4 million or 46.7% of GEMS funds; documents for the loan to the Department of Education is currently being finalized and expected to be executed on July 31, 2017; on July 21st, the Authority filed a Motion for Modification of DBEDT's Application with the PUC to eliminate the Program Notification and Program Modification process; and as of the report date, 82.6% of the Residential loans made were to low and moderate-income households, while the off takers for 100% of the Commercial loans made were nonprofits or multi-family rental projects.

Chair Salaveria asked if there were additional questions or comments from the Members. Seeing none, Chair Salaveria asked for any comments from the public. He then called for a vote.

Nays: None.

The motion carried unanimously, 3 to 0.

V. ADJOURNMENT

Chair Salaveria asked if there were any other matters that should be brought up. Seeing none, he asked for a motion to adjourn.
